

## COMMERCIAL CATERING GAS SAFETY ASSESSMENTS

There are a wide variety of Commercial Catering Gas Safety Assessments available, those applicable to individual gas operatives will be dependent on the type of gas work undertaken. Details of these assessments are given below.

ASSESSMENTS AND TRAINING FOR COMMERCIAL CATERING GAS FITTING OPERATIVES	
Assessment Code	Assessment Summary
CCCN 1.	A full CORE assessment intended for operatives who carry out installation and maintenance work on pipework, appliances and equipment on commercial catering natural gas installations.  THIS IS A PREREQUISITE ASSESSMENT TO COMCAT 1., COMCAT 2., & COMCAT 3.
CCCN 1. (reduced criteria)	A limited version of assessment CCCN 1. above designed for operatives who already hold commercial core assessment COCN 1. and intend to extend their scope of work to include commercial catering natural gas installations.  ALTERNATIVE PREREQUISITE ASSESSMENT TO COMCAT 1., COMCAT 2., & COMCAT 3.
COMCAT 1.	An assessment to extend an operatives scope of work to include the installation and maintenance of commercial catering appliances listed in Table 1 overleaf.
COMCAT 2.	An assessment to extend an operatives scope of work to include the installation and maintenance of commercial catering appliances listed in Table 2 overleaf.
COMCAT 3.	An assessment to extend an operatives scope of work to include the installation and maintenance of commercial catering appliances listed in Table 3 overleaf.
Combined Catering Appliances	A combination of all two catering appliance assessments, COMCAT 1., & COMCAT 3. listed above.
CoDC 1.	A changeover CORE assessment for an operative who already holds domestic core assessment CCN 1. and intends to extend their scope of work to include carrying out installation and maintenance work on pipework, appliances and equipment on commercial catering natural gas installations.
CoCATA 1.	A changeover assessment for an operative who already holds domestic core assessment CCN 1. and changeover assessment CoDC 1. and intends to extend their scope of work to include the installation and maintenance of commercial catering appliances listed in Tables 1 to 3 overleaf.

The following additional assessments may be required should the gas operative undertake work on installation pipework that is out of scope of BS 6173 : 2001 - Installation of gas fired catering appliances for use in all types of catering establishments.

ADDITIONAL ASSESSMENTS AND TRAINING FOR INSTALLATION PIPEWORK	
Assessment Code	Assessment Summary
ICPN 1.	An assessment to extend an operatives scope of work to include steel, copper and polyethylene pipework & fittings up to 150 mm.
TPCP 1.	An assessment to extend an operatives scope of work to include soundness testing & purging of all pipework systems in accordance with IGE/UP/1.
TPCP 1A.	An assessment to extend an operatives scope of work to include soundness testing & direct purging of SMALL pipework systems in accordance with IGE/UP/1A.
