

There are a wide variety of Commercial Gas Safety Assessments available, those applicable to individual gas operatives will be dependent on the type of gas work undertaken. The following tables document the applicable assessments for the different types of operative recognised by the GAS SAFE register and the ACS Scheme.

ASSESSMENTS AND TRAINING FOR GENERAL GAS FITTING OPERATIVES	
Assessment Code	Assessment Summary
COCN 1.	A full core assessment intended for operatives who carry out installation and maintenance work on pipework, appliances and other plant / equipment on industrial and commercial premises. THIS IS A PREREQUISITE TO ALL OTHER ASSESSMENTS IN THIS TABLE.
CoDNCO 1.	A changeover core assessment for an operative who already holds DOMESTIC core assessment CCN 1. and intends to extend their scope of work to include carrying out installation and maintenance work on pipework, appliances and other plant / equipment on industrial and commercial premises. ALTERNATIVE PREREQUISITE ASSESSMENT.
ICPN 1.	An assessment to extend an operatives scope of work to include steel, copper and polyethylene pipework and fittings.
TPCP 1.	An assessment to extend an operatives scope of work to include soundness testing & purging of all pipework systems in accordance with IGE/UP1.
TPCP 1A.	An assessment to extend an operatives scope of work to include soundness testing & direct purging of SMALL pipework systems in accordance with IGE/UP1A.
CIGA 1	An assessment to extend an operatives scope of work to include the installation, commissioning and maintenance of INDIRECT fired heating appliances and equipment.
CORT 1	An assessment to extend an operatives scope of work to include the installation, commissioning and maintenance of overhead radiant heating appliances and equipment.
CDGA 1	An assessment to extend an operatives scope of work to include the installation, commissioning and maintenance of DIRECT fired heating appliances and equipment.
Combined Appliances including CIGA 1, CORT 1, CDGA 1.	A combination of all four appliance assessments (CIGA 1, CORT 1, & CDGA 1.). This training program & associated assessments can only be booked and completed as part of a pre-tailored package.
CGFE 1. **	An assessment to extend an operatives scope of work to include the installation, commissioning and maintenance of gas fuelled ignition engines.
CBHP 1.	An assessment to extend an operatives scope of work to include the installation, commissioning and maintenance of gas boosters / compressors & high pressure pipework.
* ICPN 1 training is included in the COCN 1 / CoDNCO 1. training package.	
** Applicants for CGFE 1 MUST have prior experience of working with Gas Fuelled Ignition Engines

ASSESSMENTS AND TRAINING FOR PIPE FITTERS / COMMISSIONERS	
Assessment Code	Assessment Summary
COCNPI 1LS.	A limited scope core assessment intended for operatives who only carry out installation and maintenance work on pipework systems on industrial and commercial premises. THIS IS A PREREQUISITE TO ALL OTHER ASSESSMENTS IN THIS TABLE.
ICPN 1.	An assessment to extend an operatives scope of work to include steel, copper and polyethylene pipework and fittings.
TPCP 1.	An assessment to extend an operatives scope of work to include soundness testing & purging of all pipework systems in accordance with IGE/UP1.
TPCP 1A.	An assessment to extend an operatives scope of work to include soundness testing & direct purging of SMALL pipework systems in accordance with IGE/UP1A.
* ICPN 1 training is included in the COCNPI 1LS. training package.	

The table above highlights the assessments and associated training that would be applicable to operatives whose work ONLY includes the INSTALLATION AND MAINTENANCE OF PIPEWORK systems on industrial and commercial premises.

ASSESSMENTS AND TRAINING FOR PIPE / APPLIANCE INSTALLERS	
Assessment Code	Assessment Summary
ICPN 1LS.	An assessment to include on an operatives scope of work the first fixing of steel, copper and polyethylene pipework and fittings.
ICAE 1LS.	An assessment to include on an operatives scope of work the first fix installation of industrial and commercial appliances and equipment.
THERE ARE NO PRE REQUISITE ASSESSMENTS TO THE ABOVE	

The table above highlights the assessments and associated training that would be applicable to operatives whose work ONLY includes the FIRST FIX INSTALLATION of PIPEWORK / APPLIANCES on industrial and commercial premises (These operative DO NOT connect to a live gas supply).
