

There are a wide variety of Domestic Natural Gas Safety Assessments available, those applicable to individual gas operatives will be dependent on the type of gas work undertaken. Details of these assessments are given below.

ASSESSMENTS AND TRAINING FOR DOMESTIC GAS FITTING OPERATIVES	
Assessment Code	Assessment Summary
CCN 1. <small>(Initial & Re-Assessment)</small>	A full core assessment intended for operatives who carry out installation and maintenance work on pipework, appliances and equipment on domestic natural gas installations. THIS IS A PREREQUISITE TO ALL OTHER ASSESSMENTS IN THIS TABLE.
CENWAT. <small>(Initial & Re-Assessment)</small>	An assessment to extend an operatives scope of work to include the installation and maintenance of domestic gas fired central heating boilers / hot water circulators/Instantaneous water heaters.
CKR 1. <small>(Initial & Re-Assessment)</small>	An assessment to extend an operatives scope of work to include the installation and maintenance of domestic gas fired cookers.
HTR 1. <small>(Initial & Re-Assessment)</small>	An assessment to extend an operatives scope of work to include the installation and maintenance of domestic gas fired space heaters (including gas fires and wall heaters).
DAH 1. <small>(Initial & Re-Assessment)</small>	An assessment to extend an operatives scope of work to include the installation and maintenance of domestic gas fired warm air heating appliances.
LAU 1. <small>(Initial & Re-Assessment)</small>	An assessment to extend an operatives scope of work to include the installation and maintenance of domestic gas fired tumble dryers.
CPA 1. <small>(Initial & Re-Assessment)</small>	An assessment to extend an operatives scope of work to include combustion analysis of domestic gas appliances when commissioning ,re-commissioning or completing repairs
MET 1. <small>(Initial & Re-Assessment)</small>	An assessment to extend an operatives scope of work to include the installation, exchange and disconnection of domestic gas meters (see also REGT 1).
CMDDA 1	An assessment to extend an operatives scope of work to include Carbon Monoxide / Carbon Dioxide atmosphere and appliance testing using electronic portal gas analysers
Combined Domestic Appliances 1 <small>(Initial & Re-Assessment)</small>	A combination of up to THREE appliance assessments. This training program & associated assessments can only be booked & completed if CCN 1 has been previously undertaken. (Any 3 from CEN 1, CKR 1, HTR 1, WAT 1, LAU 1 or LEI 1)
Combined Domestic Appliances 2 <small>(Initial & Re-Assessment)</small>	A combination of TWO appliance assessments (including DAH 1) This training program & associated assessments can only be booked & completed if CCN 1 has been previously undertaken. (DAH 1 + 1 from CEN 1, CKR 1, HTR 1, WAT 1, LAU 1 or LEI 1)

The table above highlights the assessments and associated training that would be applicable to operatives who are undertaking Domestic Natural Gas Safety Assessments for the first time or who have allowed their existing ACS Certificates of Competence to expire by more than 12 months or hold a City & Guilds S/NVQ in Domestic Natural Gas (ACS Aligned) that was awarded greater than 6 years ago.

These options may also be used by operatives who already hold ACS Certificates of Competence or an 'ACS Aligned' City & Guilds S/NVQ that are within the timescales documented.
